Range and Match News

Greg Sullivan presented plans for the high power rifle silhouette range (the 600-yard range) at the April meeting. This will be a huge project, our most ambitious yet. This range will be situated on the upper level of our property, requiring the construction of a large 8- or 10-foot berm to block it from the lower ranges. The total estimated cost, including berm, drainage, backstops, shed, parking, and gravel road, comes to approximately \$75,000.00 to \$88,000.00. A motion was made to allocate \$45,000.00 for phase one of the project, which would cover the cost of the main berm construction. (The rest would be covered in a second phase next year.) The motion was seconded and passed.

Because of the size of this initial allocation, a follow-up vote is required at the May 14 club meeting.

In other news, a motion was made to require all club members to wear their badges while on the range, as an aid to identification and confirmation of membership. After a brief discussion, it was decided to table this motion and take it up at the upcoming bylaws meeting.

Finally, the land sale deal with Sardis Water Association Public Water Authority (SWAPWA) was closed on March 26. They would like to once again express thanks to the members of the club for approving the sale. No date has been announced for the start of construction, but it may begin sometime this fall.

As an additional thank you to club members, SWAPWA donated a \$200 gift certificate to Gander Mountain. The drawing for this certificate was held at the April meeting, and the winner was...Albert Hall. Congratulations, Albert!
