Range and Match News

The 2006 Arkansas State Smallbore Rifle Silhouette Championship match was a huge success. More than 60 competitors from five states took part, taking home \$7,500.00 in prizes. Out thanks for everyone for their help and support. Results can be found on the club website. Frank Bray is already looking ahead to next year, and made a number of motions at the October club meeting.

The first motion was a request for \$1,200.00 for the Smallbore Rifle Silhouette regional match to be held on March 17, 2007. The motion was seconded and passed, and a follow-up vote will be held at next month's meeting.

The next motion was a request for \$750 to cover the expenses of sending club member George Rhode to the January SHOT show in Florida. This gun show is where we promote the Smallbore Rifle Silhouette state championship match and recruit sponsors who donate the prizes. The motion was seconded and passed.

Frank's third motion was a request to budget \$4,500.00 for the 2007 state championship match. This motion was tabled pending a final tabulation of the expenses for this year's match.

In other news, James Squires made a motion to purchase an electronic target thrower for the shotgun range, at a cost of \$750.00. The motion was seconded and passed.

Pat Holsted made a motion to purchase a "Texas Star" rotating steel target at a cost not to exceed \$1,000.00. The motion was seconded and passed. (As it turns out, the actual cost was \$593.00.)

Pat also made a motion to have the club join the U.S. Practical Shooting Association, so that we may hold sanction USPSA matches at the range. Membership costs \$65.00 per year. The motion was seconded and passed. We hope to have a number of USPSA-approved matches on next year's schedule.

Finally, a motion was made to host a match director's dinner to set the schedule for 2007. This motion was also seconded and passed. Paul Stiedle will coordinate the plans.

2007 Dues To Remain Unchanged

Last month at the September club meeting, two motions were made regarding club dues for 2007. These motions were voted on at the October meeting. The motion to raise the dues to \$75.00 was defeated. The motion to keep the dues at \$60.00 was passed.

NOTE TO THOSE WHO ARE GIVING ORIENTATIONS: After you give a member the re-orientation, please sign and date the back of his or her membership card. We need this as a double check in case an attendance sheet is lost.

Please Observe All Range Rules

Someone has been using high-powered rifles on lower range 2. This range is for **smallbore rifles only**. Anyone observed violating the club range and safety rules is subject to dismissal from the club. New members, make sure that you know what type of firearm may be used on each range. If you don't know, read your bylaws.

We'd like to remind club members not to move target stands closer to the sheds or pads. All target stands must be placed directly in front of a designated berm or backstop. Failure to comply with this rule, or any other range rule, may result in revocation of your membership.

Also, if you decide to burn trash in the barrels on the range, please check first to make sure a state, county or local burn ban is not in effect.
